- 1) The meeting was called to order by Dr. Woods after noting the presence of a quorum.
- 2) Approval of <u>minutes</u> from the meeting held 20 December 2018: Motion by Dr. Woods, Second by Ms. Hale, all in favor.
- 3) Approval of <u>Claims Vouchers</u>: Vouchers were reviewed and approved on Motion by Ms. Morgan, Second by Dr. Mowery, all in favor.
- 4) Health Administrator Performance Report
 - December:
 - \$5,280 December receipts; \$36,209.44 YTD; up \$15,000 from year prior
 - On-Site Sewage: few soil reports reviewed
 - Foods: 6 inspections, 2 follow-up inspections
 - PHN: 2 animal bites; 3 Epi; no new hepatitis cases; 0 TB; 1 pending lead case
 - Vaccines: 43 (11 VFC, 31 Vaxcare, 1 317)
 - 4 PPD
 - 960 Vaccines/PPD 2018 Total
 - · School flyers with new vaccine requirements distributed
 - Jail Hepatitis A mass vaccine clinic schedule February 4.5
 - Discussed school closure rate of 20% threshold for absentee due communicable disease. Local schools' flu rates are well below that at present.
 - STD: December: 2 chlamydia, 1 gonorrhea. 2018: 54 chlamydia, 7 gonorrhea.

 <u>Board Reappointments</u>: Dr. Mowery and Ms. Dugan were reappointed by the Commissioners.

- Open House: Will be scheduled February 28 from 1-4 PM.

- Advertising: WTWO provided an estimate for TV advertising. Also estimate of \$400 each
 for 5 minute special segment in which the Health Department would have rights to a
 promotional video. Commercial segments were discussed. After a discussion,
 consensus was to avoid TV advertising, investigate local WNDI radio spots, and pursue
 the 5 minute video segments if appropriate.
- <u>Pest Control</u>: There have been live ants and old dead bugs. May need pest control services in the new building. Will attempt to piggy back onto the courthouse plan. If not possible, will obtain services from a local vendor.
- <u>Window advertising</u>: A quote was received for a digital sign. At this time that is not viable. Obtaining quote for simple sign insert. Also have quotes for window appliqués and plan to have those installed as soon as weather permits.
- Annual Report for <u>ISDH Carry-over</u>: Trust has \$118, 823.86 and Local Health Maintenance Fund has \$102,410.49. The forms were signed to be submitted to the ISDH.
