

SULLIVAN COUNTY COUNCIL MEETING MINUTES – OCTOBER 28, 2019

Duane asked everyone to stand and recite the Pledge of Allegiance.

Roll Call

Duane called roll, members present: Duane Wampler, Larry Kinnett, Tim Abrams, Nick Cullison and Curt Bedwell, member absent; Logan Pearson.

Minutes

Shelly presented two sets of minutes, the council had not had a chance to read them, approval tabled until the next meeting.

SHELLY PRESENTED TRANSFERS AND ADDITIONAL APPROPRIATIONS

Vicki Talpas, Assessor – Claim for ICS Innovative \$3,599.00 Upgrade to server, she wants to transfer the amount from her disclosure fund, she has \$5,724.79 and paying this claim would leave her \$2,125.79.

Tim made a motion to approve transfer, seconded by Nick, all approved, motion passed.

Judge Hunley, Circuit Court– has several transfers to make and two appropriations

Transfer \$500.00 from Misc. Supplies to Depositions / Transcript

Transfer \$4,000.00 from Bailiff to Pauper Counsel

Transfer \$4000,00 from to Pauper Counsel

Transfer \$1,500.00 from Expert Testimony to Pauper Counsel

Transfer \$1,500.00 from Maint. Repair to Pauper Counsel

Transfer \$150.00 from Printing to Pauper Counsel

Additional Appropriation of \$30,000.00 into Pauper Counsel

Additional Appropriation of \$15,000.00 into Detention

Tim Abrams Made a motion to allow the Transfers and Additional Appropriations, seconded by Larry. All in favor motion passed.

Judge Hunt, Superior Court – had requested a transfer of \$50,000.0 during the budget hearing which was approved, but the required form was not submitted, Judge Hunt appeared before

the Council asking for the additional amount of \$50,000.00 plus an additional \$15,000.00 making it a total of \$65,000.00. Jerry Payne made a motion to allow the Additional Appropriation of \$65,000.00 seconded by Nick, all in favor motion passed.

Barb Montgomery – Transfer of \$16,000.00 from Adult Probation to New Equipment for New computers due to their needing to be Windows 10 to be compatible with Odyssey System. Tim made a motion to approve the Additional Appropriation, Nick seconded, all in favor, motion passed.

Shelly, Auditor – Transfer from Postage to Office Supplies in the amount of \$285.00 And Transfer from Dues to Office Supplies in the amount of \$212.24, Tim made a motion to allow the Transfer, Nick seconded, all in favor, motion passed.

Shelly - Additional Appropriation to bring the Salary Ordinance in line with the budget
The total amount of \$12,023.00 is needed in order to bring the 2019 Salary Ordinance in line with the 2019 Budget, See Exhibit "A" – List of Additional Appropriations to bring the Salary Ordinance in Line with the Budget. See Exhibit "B", 2019 Salary Ordinance, was signed by the Sullivan County Council Members present.

Tim made a motion to approve all Additional Appropriations to Salary Ordinance, seconded by Jerry, all in favor approved.

Solid Waste Budget Ordinance

Shelly presented the Solid Waste Budget Ordinance to the Council to be signed. After some discussion Tim made a motion to sign the Solid Waste Budget Ordinance, Larry seconded, all in favor, motion passed.

Old Business

Josh Reshey

Josh presented the Salary Ordinance Amending the Compensation for the Sullivan County Sheriff, see Exhibit "C", that he had prepared to correct Sheriff Clark Cottom's salary. The Ordinance was sent to the State Board of Accounts for their approval. Nick made a motion approve the Salary Ordinance correction for Sheriff Clark Cottom, Tim seconded, all in favor, motion passed.

(Please note: An elected Officials salary cannot be amended in the Salary Ordinance during the year the official is serving, except in accordance with IC 36-2-13-2.8; Sullivan County must pay the Sheriff a minimum annual salary that is at least sixty percent (60%) of the annual salary paid

to a fulltime prosecuting Attorney. The Indiana Supreme Court set the 2019 fulltime Prosecuting Attorney's minimum salary at \$147,164.00)

NEW BUSINESS

Ryan Keller

Executive Director of West Central Indiana Economic Development District, Inc. Mr. Keller came to the Council meeting to introduce himself, and meet the Council and let them know that WCIEDD would be there to help if Sullivan County needed assistance.

Beth Cole Reed






ORDINANCE NO. 2019-_____

**AN ORDINANCE AMENDING THE COMPENSATION
FOR THE SULLIVAN COUNTY SHERIFF**

WHEREAS, this Ordinance is adopted by the Sullivan County Council (the "Council"), of Sullivan County, Indiana, and witness:

WHEREAS, the Sullivan County Sheriff is paid by Sullivan County from the County's general fund in the manner that salaries of other county officials are paid pursuant to IC 36-2-13-2.8;

WHEREAS, pursuant to IC 36-2-13-2.8(c)(2), the County *must* pay the sheriff an annual salary that is at least sixty percent (60%) of the annual minimum salary that would be paid by the state to a full-time prosecuting attorney in the county;

WHEREAS, in 2019 the minimum salary paid by the state for a full-time prosecutor is \$147,164.00;

WHEREAS, in 2019 the minimum salary by law for the Sullivan County Sheriff is \$88,298.40;

WHEREAS, the 2019 salary ordinance incorrectly set the Sullivan County Sheriff's salary at \$87,298.40;


WHEREAS, the Sullivan County Council wishes to amend and correct its 2019 salary ordinance for the Sullivan County Sheriff in order to comply with the minimum salary requirements of the Indiana Code;

WHEREAS, the Sullivan County Council would need to increase the 2019 salary of the Sullivan County Sheriff by \$1,096.40 to comply with the minimum salary requirements set forth in IC 36-2-13-2.8(c)(2);

NOW, THEREFORE, BE IT ORDAINED BY THE SULLIVAN COUNTY COUNCIL OF SULLIVAN, INDIANA, THAT


The 2019 salary of the Sullivan County Sheriff is hereby amended and corrected to a yearly salary of \$88,298.40, which is an increase of \$1,096.40. This change and increase in salary is to take immediate effect.
