#### **OLD BUSINESS**

County Commissioners - Bob Davis, President Sullivan County Commissioners presented the

Commissioners Plan for the OneAmerica

Employees currently receive \$1,400.00 per year.

Commissioners are proposing \$1,800.00 per year and in addition, if the employees will put up to an additional \$900.00, the Commissioners will match up to the \$900.00. That would be around

\$150, 000.00 more than what we are paying now. The employees still have the ability to get to their funds in case of a serious emergency, which would be an IRS regulated emergency.

If the employee puts in \$900.00 the county would be putting in \$2,700.00.

Discussion on the Commissioners plan, as to where the money would be coming from. The Commissioners will have roughly \$150,000 left over from the jail project and the following years

They can use the money that was set aside for an ambulance after 2021.

#### PERF

Curt said that they voted on PERF and there was a resolution, just because it was not submitted, he received a letter from PERF stating that they were still expecting us to comply with resolution.

Duane took a poll from the Council asking each member if they had ever seen the resolution before it was sent in to PERF. Duane started with Nick, Tim, jerry, Larry and Logan and all said no.

Shelly spoke and gave her reasons for not following through with the signing and sending in the Paperwork to PERF to put the count into PERF.

Luke asked Curt if he had spoken with PERF, Curt said they accepted the resolution

Duane said that it was never read in an open meeting and voted on.

Bob Davis said Tim, the Commissioners are ready to start January 1, 2021 with their plan.

Ray asked the Council if they were keeping Terry Modesitt apprised of the Sullivan Solar.

A gentleman asked to speak as a taxpayer that the they are still trying to stuff something down our throats. They need to speak plain and use microphones. He has to live within his means.

Motion to adjourn by Nick,

Logan stated that he had additional transfers tor Tonya Bidwell's office from programming to precinct boxes \$500.00 tabled until next time.
